There may still be compatibility issues, RH is not a part of compliance program. RHOSP 13 is bundled with upstream openstack Tempest 18 version - this is what HPE heard from RH. <p>Yardstick HA Tests: Four tests result in restoration with outages more that twice the SLA (5 seconds). These are the API restoration/response results.</p> <ul style="list-style-type: none"> • Other implementations have passed these SLAs, BUT this is a trade-off between stability and restoration time. Recommendation is to include the Quantitative results as part of any statement on Exceptions (this is indicative of the general problem with threshold applicability). <p>vping tests: Additional log files show that the vping tests have passed (different from the log file on the Dovetail portal site).</p> <ul style="list-style-type: none"> • Would like to know the specific reasons for failure – but Functest versions can't be run at the moment – vacation. <p>Bottlenecks Stress Tests: Bottlenecks Log file shows PASS, Dovetail Log file shows FAIL.</p> <ul style="list-style-type: none"> • Apparent Dovetail issue.
